EBIDTA was Rs.310.96 lakhs for the quarter ended 31st December 2014 and Rs. 1242.23 lakhs for the nine months ended as on that date, up 18.52%, YoY.

Net Profit after tax was Rs.190.54 lakhs for the quarter ended 31st December 2014 while for the nine months ended 31st December, 2014 it was Rs. 741.94 lakhs, up 0.98% YoY.

Earnings per share was Rs.3.81 for the quarter ended 31st December 2014 and Rs. 14.84 for the nine months ended as on that date.
