Revenue from operations stood at Rs.1994.15 lakhs an increase of 7.39% QoQ

EBIDTA was at Rs.376.79 lakhs , up 42.21% YoY.

Net Profit after tax was at Rs.213.50 lakhs, up 277.07% QoQ and 46.08% YoY

Earnings per share stood at Rs. 4.23 , up 42.42% YoY.

Revenue from operations stood at Rs. 2097.58 lakhs, an increase of 7.09% QoQ

EBIDTA was at Rs.390.90 lakhs , up 58.00% YoY.

Net Profit after tax was at Rs.203.45 lakhs., up 72.86% YoY

Earnings per share stood at Rs. 4.55 , up 79.13% YoY.
