In terms of the circulars, the Company had sent the Notice to the shareholders on January 07, 2026, in electronic form.

The e-voting commenced on Thursday, January 08, 2026 at 9:00 A.M. (IST) and ended on Friday, February 06, 2026 at 5:00 P.M. (IST). The Shareholders of the Company holding shares as on the “cut-off” date of Friday, January 02, 2026 were entitled to vote on the resolutions contained in the Notice of the Postal Ballot.

A newspaper advertisement was published on Thursday, January 08, 2026 in 'Financial Express' (English language newspaper) and in 'Hosadiganta' (Kannada language newspaper) specifying the details of dispatch of Notice and instructions for e-voting.


